- The Company is engaged in the manufacture and marketing of Metal and Alloys which in the context of Indian Accounting Standard (Ind AS) -108 Operating Segments, is considered as the operating segment of the Company.
- The Company elected to exercise the option permitted under Section 115BAA of the Income Tax Act, 1961 for the year ending 31st March, 2022. Accordingly, the Company has recognized Provision for Income Tax for the quarter and nine months ended 31st December, 2021 and measured its Deferred Tax Assets and Liabilities based on the rates prescribed in the said section.
- The Company is closely monitoring the impact of the Covid-19 Pandemic on all aspects of its business, including its impact on Customers, Employees, Vendors and Business Partners. Based on the current estimates, the Company expects to fully recover the carrying amount of assets and does not foresee any significant impact on its operations. The Company will continue to closely monitor any material changes to future economic conditions.

We have reviewed the unaudited interim financial results of Pondy Oxides and Chemicals Limited (the "Company") for the Quarter and Nine months ended 31st December 2021 which are included in the accompanying 'Statement of Unaudited Financial Results for the Quarter and Nine months ended 31st December, 2021'.
