Brief of the amendments made in Articles of Association of the Company

Sl No.	Amendment(s)
1.	The Companies Act, 2013 ("the Act) has been amended frequently by way of notifications and amendment Acts. In view of frequent changes, it was thought fit by the Board of Directors of the Company that certain clauses of the existing AOA which were based on the provisions of Companies Act 1956 of the Company should be amended/modified in accordance with the provisions of the Companies Act 2013 and necessary rules framed thereunder.
	The New AOA has been restructured and aligned with the provisions of the Act, the Secretarial Standards issued by the Institute of Company Secretaries of India and other applicable laws. References to the sections, sub-sections, clauses etc. of the Act, which have been amended are substituted with the new provisions of the Act;
2.	The new AOA to be substituted in place of the existing AOA is based on "Table-F" of the Act which sets out the model AOA for a company limited by shares, Provisions of the Act, which permit the Company to do certain acts when authorised by AOA, or, which require the Company to do acts in a prescribed manner unless the AOA otherwise provides, have been specifically included.
